Kindly refer to your RTI application dated 22.04.2016 received in this office on 22.04.2016. In this respect, point wise information is as follows: -


1. With respect to Point No. 1, it is informed that this office made certain observations in the Medical Reimbursement case submitted by Mr. Prem Narayan, and was informed to remove the shortfalls vide this office letter no. 12-1/95-Estt/NCAP (Part-III) dated 21/23.03.2016 and 19.02.2016. Afterwards the bill was prepared on 15.03.2016 and sent to Finance & Accounts for payment after getting the required clarifications from the applicant. For copies of related notings, you are requested to deposit Rs. 36/- @ Rs. 2/- per page for 18 copies.
2. With respect to Point No. 2, it is informed that with respect to your letter dated 02.01.2016, the office informed you about the shortfalls in the medical bills and requested you to furnish the required information vide this office letter no. 12-1/95-Estt/NCAP (Part-III) dated 21/23.03.2016.
3. With respect to Point No. 3, it is informed that this office is not in receipt of any such letter dated 26.01.2016.
4. With respect to Point No. 4, it is informed that a meeting with you was held on 04.05.2016 where you have stated that the issue of payment of Medi-claim has been settled by the office.
5. With respect to Point No. 5, no such letter dated 28.01.2016 sent by you is available in this office.
6. With respect to Point No. 6, no such letter dated 26.02.2016 sent by you is available in this office.
7. With respect to Point No. 7, it is informed that the information is not available in the format as requested thus cannot be provided in the format requested by the applicant as it will disproportionately divert the resources of this office. However, you can come to this office and inspect the related records. The fee structure for inspecting the documents is as follows: -
